DAY 13: WHISTLER

After breakfast take a trip on the Gondola for panoramic views of the Village and surrounding mountains, make sure to cross the Peak2Peak Gondola from Whistler to Blackcomb Mountain – a unique experience! Time at leisure for shopping and sightseeing. Overnight in Whistler.



DAY 14: WHISTLER – KAMLOOPS

After breakfast proceed From Whistler to Kamloops drive through scenic drive. Arrive Kamloops after 6 hrs.

DAY 16: JASPER

After breakfast explore the charming town site of Jasper that developed from “jasper house”, a former settlement of three log supply houses for rocky mountain voyagers. Highlights of your tour include Pyramid and Patricia lakes and the beautiful Malinje Canyon, with its limestone walls falling a stunning 50 meters. DAY 17: JASPER - BANFF

Today travel along the Ice field Parkway, one of the world's most beautiful highways, passing some of Canada's highest mountains and most magnificent glaciers. Stop at Bow Lake, Crowfoot Glacier and pass by Peyto Lake before reaching the Columbia Icefield, which is one of the largest accumulations of ice south of the Arctic Circle. Take a ride on the Ice Explorer onto the Athabasca Glacier for a close look at the ice formations. Overnight in Banff.





DAY 18: BANFF - LAKE LOUISE - BANFF

After breakfast proceed for Yoho National Park where you will see the Natural Bridge of stone and beautiful Emerald Lake. Return to Banff National Park and explore the Valley of the Ten Peaks and scenic Moraine Lake. Finally, arrive at picturesque Lake Louise where you will admire the reflection of the Victoria Glacier onto the turquoise blue waters of Lake Louise. Enjoy a ride on the Lake Louise Gondola which offers panoramic views of the lake, glacier and surrounding mountains. Overnight in Banff.

TERMS AND CONDITIONS

We at Urvi Luxury Destination, make the best effort to provide you the best service in a pleasant & friendly atmosphere. We strive for your complete satisfaction and endeavour to provide a safe & secure holiday without any misunderstandings between the company, the tour leaders and you at any point of time during your holiday. Therefore, we request you to read and understand the booking conditions for your holiday, before you enrol yourself for any of our tours / packages. The terms and conditions as stated below forms the basis of our contract with you.

CONTRACT : All the tours are operated by Urvi Luxury destination. When you book the tour, it is a contract between you & the tour company. All the bookings are accepted only on the basis that you have thoroughly gone through these mentioned terms and conditions.

BOOKING & CONTRACT : The registration amount given at the time of booking is non – refundable and non – transferrable. The bookings will be processed by the tour company only after the registration amount is paid in full. Full or balance payments should be made 45 days prior to the date of departure. If the tourist fails to pay timely full amount, then the tour company reserves the right to cancel the booking with forfeiting the paid amount. In case of dishonoured cheques issued by the tourist in favour of the company, the company reserves the right to take necessary legal actions and the company has full right to cancel the bookings.

TAXATION : A non – negotiable and mandatory Goods and Service Tax (GST) at the rate of 5% & also Tax Collected at Source w.e.f. 1st April 2020 (TCS) at the rate of 5% is applicable over & above the land package cost. In case of any imposed tax by the Government of India over and above the proposed taxes, then the tourist will be liable to pay even after the bookings has been done.

AIRLINES & TICKET : The company won't be responsible in case of any Airlines delay or deficiency.
